On Tuesday, October 22, 2019 Councilmember Trayon White Sr., Chairperson of the Committee on Recreation and Youth Affairs, will hold a public roundtable on strategies to reduce youth violence. The roundtable will be held in the Auditorium of Savoy Elementary School, 2400 Shannon Pl SE, Washington D.C. 20020 at 6:30 p.m.

The purpose of this roundtable is to highlight positive impact that the Department of Youth Rehabilitation Services is having on youth through programs like Credible Messengers and Restorative Justice Circles, identify the key areas of influence that the programs have in the community, and discuss how that impact can be broadened to the community at large with the goal being to reduce youth violence.

The Committee invites the public to testify or to submit written testimony, which will be made part of the official record. If you are unable to testify at the roundtable, written statements are encouraged and will be made part of the official record.
